### Conditions of Riding Membership

1. Parents/caregivers of each family, agree to assist with at least 3 rallies/working bees and 2 events per season, or with alternative tasks agreed to by the committee (12hrs per family per season).
2. For those unable or unwilling to assist with rallies, working bees, events or other tasks, there is a levy of \$400 per season.
3. Parents/Caregivers accept that they must be responsible for their children's riding at all times. Riders aged 16 years and under must be supervised by an adult while on club grounds.
4. All riders must have a companion who is capable of calling for assistance if they intend to do any form of jumping.
5. All riders and families must respect the security of the club by not passing on the combination padlock codes to non-members.

2 <sup>nd</sup> and 3 <sup>rd</sup> Pony club rider U25 years old (member of same family)	\$200 plus NZPCA levy of \$40 and Auckland Area levy of \$35
Adult parent/caregiver fee (for parents of riders U18 years old)	\$15 NZPCA
Parent adult riding member (only applies to parent of pony club rider U18)	\$200 plus NZPCA levy of \$15
Working Bee levy per family	\$400

Applications for membership will be considered by the committee. All proposed new members aged under 25 years who intend to take part in rallies, must attend a rally mounted before their application can be approved. We will send you rally details on receipt of your application form, you will need to confirm which rally you are attending by the Tuesday before the relevant rally.

Upon acceptance of this application, all fees must be paid prior to using the grounds and/or the start of rallies. Failure to pay means you cannot attend rallies nor use the grounds and facilities.

NZPCA requires all Pony Club members to be signed up to their national database Nominate. We will give you further instructions once membership is approved. Payments are to be made through Nominate for all new members and on renewal each year.

For existing members, membership may lapse if subscriptions and levies are not paid by the 20th September (or by an alternative date agreed on by the Committee).

Should membership lapse for more than 1 year, the joining fee may be required to rejoin. This is at the discretion of the committee.
